

# AUTHOR-INDEX TO THE UNIVERSITY OF CEYLON

## VOLS. 1 - XXV

### Compiler's Note:

The following author-index covers Vols. I-XXV of the *University of Ceylon Review*, spanning the entire period of its publication from 1943 to 1967.

At various times during its existence the *Review* published alphabetical indices. These are, however, not readily accessible; and it is hoped, therefore, that this author-index will prove useful, not only to scholars in the various academic disciplines, but also to all those interested in the history of higher education in Sri Lanka.

In the preparation of this author-index, all known issues of each volume have been consulted, but it should be pointed out that there is no consistency whatsoever either with regard to the number and frequency of issues per volume, or with regard to the pagination of successive issues of each volume. This is hardly surprising for a journal which existed as long as a quarter century, passing through many vicissitudes and a number of editorial hands.

Consistency is also lacking in the transcription of some of the names of contributors. For instance, Prof. T. Nadaraja's surname occurs in a variety of forms, while "Lanarolle" and "Lanerolle" are used indiscriminately. Other alterations, however, reflect a change of policy on the part of the contributors themselves with regard to the form of their names. Thus, in his earliest contributions Prof. Sarathchandra's initials are given as "E.R. de S." while in later issues the form "E.R. Sarathchandra" occur regularly. (I have not encountered the form "Sarachchandra" which is currently used). In all such cases I have taken the liberty of keeping to the one form that is most frequent, in order to avoid confusion and to maintain the chronological sequence of the items from each contributor. In particular, no account has been taken of changes subsequent to an author's most recent contribution to the *Review*. Contributors of book-reviews are indicated in this journal mainly by their initials, and in all such cases the presumed surname has been enclosed in parantheses in the present index.

Apart from providing a means of publication for smaller pieces of research undertaken by the academic staff of the University, the *University of Ceylon Review*, together with the *Ceylon Journal of Science*, made possible the rapid growth of the University Library's periodical collection through a large number of exchanges.

The first two volumes, each comprising of two parts, were brought out under the sole editorship of Professor G.P. Malalasekera, but subsequent volumes had two editors, representing the two faculties, namely those of Arts and Oriental Studies. Still later, a third editor represented, in some cases, the Faculty of Law.

Although the shift to Peradeniya inevitably caused temporary disruption of many activities, publication of the *Review* was uninterrupted, and came to an end only in 1967 with Vol. XXV edited by Professors P.E.E. Fernando, W. J. F. Labrooy and K. W. Goonewardena.

The *Review* was replaced by two separate journals, devoted to social sciences and humanities respectively. The *Ceylon Journal of the Humanities* first came out in January, 1970 under the editorship of Kamal de Abrew; but only two volumes appeared, each consisting of two issues, covering the period 1970-1971. This Journal was in its turn succeeded by the *Sri Lanka Journal of the Humanities* which commenced in 1975 and is still being published.

An author-index to the *Sri Lanka Journal of the Humanities* (with an appendix listing articles in the two published volumes of the *Ceylon Journal of the Humanities*) is being published in the *Sri Lanka Journal of the Humanities* Vol. XVII (1991). For further information on all these journals I wish to refer the reader to the comprehensive article entitled "Orientalia in the University" by Ratna Handurukande in the same volume; and I wish to express my deep gratitude to Prof. Handurukande for constant encouragement and assistance with getting the required information for the present compilation.

I also wish to record my gratitude for assistance given by Professors Merlin Peris, Sirima Kiribamune and Ananda S. Kulasuriya, Mr. K. Selvaratnam, and by Mr. G.R. Karunaratna of the Library and B.G. Wijeratne of the Dept. of Classical Languages of the University of Peradeniya. My thanks also to Ms. B. Shanthi de Silva, Ms. Priyanga Fernando and Ms. Chandrika Ratnayaka for their kind assistance in compiling this index.
